- Canada and Bolivia established diplomatic relations in 1961 when Alfred John Pick, Canadian Ambassador to Peru, was accredited in Bolivia. Since then, the Embassy of Canada in Peru and the Program Office of the Embassy of Canada in Bolivia have been working to expand and strengthen bilateral relations.
- Diplomatic relations between Bolivia and Canada celebrate their 60 years anniversary in 2021.
- The framework of the cooperation agreement between the Plurinational State of Bolivia and Canada celebrated its 40th anniversary in December 2018. Canadian cooperation has been active in Bolivia since 1977.
- The current international cooperation program focuses on gender equality, sexual and reproductive health and rights, and inclusive growth in Bolivia.
